



COLORADO'S JUDICIAL MERIT SELECTION SYSTEM

Over 50 years of choosing judges based on merit. Not Money. Not politics.

HOW DOES IT WORK?

Three important steps keep us focused on qualifications, not politics.

- Judicial Nominating Commissions—
 Nonpartisan, citizen commissions with a majority of non-lawyers review applications and nominate candidates to the governor.
 The governor selects one of them.
- Judicial Performance and Retention
 Commissions—Nonpartisan, citizen
 commissions with a majority of nonlawyers conduct reviews of each judge's
 performance, including surveys, interviews,
 and direct observation. They assess whether
 the judge treats people fairly, applies the
 law impartially, and meets performance
 standards.
- 3. Retention Elections—After a two-year period of service, and thereafter at regular intervals, each judge stands for retention. This is a nonpartisan election in which the judges do not campaign. The public votes on whether the judge should continue to serve the people of Colorado.

FREQUENTLY ASKED QUESTIONS

- 1. Who reviews trial court candidates?
 - In each judicial district, one nonpartisan nominating commission comprised of non-lawyers and lawyers reviews trial court candidates.
- 2. Who reviews Court of Appeals and Supreme Court candidates?
 - One nonpartisan statewide nominating commission comprised of non-lawyers and lawyers reviews candidates for the Supreme Court and Court of Appeals.
- 3. What makes a good judge?
 - Knowledge, experience, skills, character, personality, and other attributes.
- 4. What does the Governor's office do?
 - Checks state and federal agency records to ensure no law violations.
 - Solicits and receives information about each applicant.
 - Interviews candidates.
 - · Appoints one.
- 5. Who gathers information about judges' performance?
 - Nonpartisan judicial performance commissions comprised of non-lawyers and lawyers evaluate the performance of all Colorado judges.
- 6. How often does each judge appear on a ballot after his or her two-year provisional term?
 - · County Court judges every four years.
 - · District Court judges every six years.
 - Court of Appeals judges every eight years.
 - · Supreme Court justices every ten years.
- 7. When do we vote on retaining judges?
 - · November of even numbered years.
